Colorado Supreme Court Recognizes the Achievements of Joseph Law Firm, P.C. in Pro Bono Commitment Program

Joseph Law Firm, P.C. is one of approximately 100 law firms, solo practitioners and in-house counsel groups in Colorado to have met an annual goal of providing an average of 50 hours of pro-bono legal services per attorney in 2009. The Colorado Supreme Court has recognized Joseph Law Firm, P.C. as fulfilling its commitment to the Pro-Bono Commitment Program. This program was created to secure an enduring commitment from Colorado's legal community, to provide free legal services to indigent people in civil matters, and to annually recognize law firms, solo practitioners and in-house counsel groups who have given generously of their time.

AILA To Boycott Arizona Anti-Immigrant Law

The Board of Governors of the American Immigrant Lawyers Association (AILA), has instructed its Executive Committee to move the Association's fall 2010 conference, previously scheduled for Arizona, to another state. This Arizona Senate Bill 1070 is considered one of the harshest anti-immigration bills passed in the U.S. in more than a decade. AILA president Bernie Wolfsdorf explained, "We cannot in good conscience spend association dollars in a state that dehumanizes the people we represent and fight for. If Arizonans are serious about ending illegal immigration, they should be the first in line at the United States Capitol to urge Congress to do the right thing and pass comprehensive immigration reform." Jeff Joseph, Esq., of Joseph Law Firm, P.C. currently serves on the 21 member AILA Board of Governors. Bill 1070 is considered to be unconstitutional and interpreted as a means to allow racial profiling by law enforcement.
